PWA Partners with EcoReserves Project

The Piscataquog Watershed Association is pleased to announce a new collaboration with the New Hampshire Ecological Reserves System Project (ERSP), which recently received U.S. Forest Service funding for a pilot project in two watersheds: the Piscataquog and the Ammonoosuc. These watersheds were selected for a variety of reasons. Between the two of them, all three ecological regions mapped by the U.S. Forest Service in the state are represented. Both watersheds also have active land trusts that can follow up on the blueprint of ecologically significant areas identified through the project.

The PWA's letter of support for this project stated in part, "The Piscataquog River watershed is 220 square miles located in south central New Hampshire, where development pressures are considerable, but open space and undeveloped lands still offer tremendous habitat for bobcat, bear, and other mammals requiring large territories, as well as habitat for rare and/or sensitive aquatic and upland plant and animal species with pecialized habitat needs."

The ERSP, a public-private partnership, has developed a number of criteria to identify ecologically significant areas: exemplary natural communities, critical wildlife habitat, uncommon geologic features, rare plant and animal populations, long-term ecological viability, and linkage to other open space. UNH Cooperative Extension coordinates the statewide partnership, which includes the Division of Forests & Lands, the Fish & Game Department, the Society for the Protection of NH Forests, The Nature Conservancy, the Department of Environmental Services, and the Audubon Society of NH. The ERSP has completed an analysis of ecological significance for eight sites. In this project, the principles and criteria used at the site level will be applied to entire watersheds. Contributing to the analysis will be aerial photographs, topographic maps, computerized geographic data, and information about the habitat requirements of various wildlife species.

Project Coordinator Ellen Snyder also is eager to use information generated by the PWA's Keeping Track program, St. Anselm College students' research, and the watershed's knowledgeable residents. Says Ellen, "This is an exciting opportunity to apply the science-based principles and criteria developed by the statewide ERSP within a watershed that spans the urban-rural continuum of land use and hosts an active and committed land trust that can strengthen and support a land stewardship ethic among watershed residents."

The project is scheduled to last through fall 2003. From it, we anticipate the creation of a permanent "scientific advisory committee" to guide the PWA's conservation priorities. Data can also be used to guide local conservation planning and state conservation funding decisions. The conservation plan that results from this project will highlight ecosystem function as a priority and suggest conservation options and management opportunities for landowners interested in working with the PWA, conservation commissions, and other conservation organizations to keep the watershed ecologically intact. We are thrilled to be working with Ellen and the other ERSP partners in this exciting undertaking, and invite interested PWA members and friends to be a part of it. To learn more, come to the introductory meeting on June 20. (See details on cover.)

## **PWA Supports Protective Flows for Rivers**

The PWA was one of 25 conservation organizations to oppose recent controversial instream flow legislation proposed by New Hampshire House representatives.

"House Bill 1449 is a water-user end run around an extensive, 10-year process

for establishing protective flows for our state's rivers," stated Dr.. Ken Kimball,

director of research for the Appalachian Mountain Club and long-time

member of the State Rivers Management Advisory Committee. "It would stop

unlimited water from the state's publicly owned rivers." The bill's sponsors were outmaneuvered on the House floor, where Durham representative and Lamprey River Advisory Committee Chair Judith Spang led a successful floor fight to kill HB 1449 and replace it with an alternative. The alternative establishes a pilot program for two rivers, the Lamprey and the Souhegan, to test the flow rules proposed by the NH Department of

Environmental Services. These

rules were compiled after an extended comment period with much input from representatives of business, industry, tourism, public water supply, and conservation and recreation interests.

The bill survived the Senate with some modifications and is en route to the Governor's desk for signature. The deadline for completion of studies on the two rivers is April 1, 2005.

WHO AM I?

In the early 1900s this species was nearly extinct due to habitat loss, but as forests matured, its population increased to healthy levels. You might see them in secluded ponds and wetlands in the spring. They search out a large tree cavity (at least 11" wide and 1' to 8' deep) to make their nest. When the young are just one day old, they jump from the nest cavity - sometimes leaping as much as 60' to the ground! The young family may then walk up to a mile to reach water.

## THANKS TO OUR VOLUNTEERS!

On April 21, an enthusiastic team led by Purple Loosestrife Awareness Committee chair Lyn Lombard dug up and potted about four dozen purple loosestrife plants that were then moved to grow in solitary confinement in backyard wading pools (to simulate wetlands). It is illegal to dig, transport, sell, or plant purple loosestrife in NH, but the PWA had a special permit from the NH Department of Environmental Services to dig a limited number of plants. These plants will be used as nurseries for this year's crop of PWA Galerucella sp. beetles. In early summer the beetles will be released into selected purple loosestrife infested wetlands. The beetles have already shown great promise for biological control of this invasive species. Joining the mud brigade this year were Ellen Dokton, Margaret Freeman, Mary Koon, Ken Lombard, Pat Myers, Karen Roy, Michael Roy, and Allison Thomson.

## Grant will Double Dollars
